NOTES

1. Separate form must be completed and submitted for each ditch requested for inclusion on the maintenance list.
2. Forms must be submitted to the Mathews County Department of Planning and Zoning either by mail at P.O. Box 839, Mathews, VA 23109 or by hand delivery to the Planning and Zoning Office, Room 208, 50 Brickbat Road, Mathews, VA 23109.
3. Ditches submitted for inclusion on the maintenance list will be considered and prioritized based upon:
 - Improvement of state highway drainage and traffic safety;
 - Project does not require realignment of existing ditch line;
 - Ditch drains water away from state highway and is not a roadside or private road ditch;
 - No environmental permitting restrictions;
 - Cost of ditch project and availability of adequate funds and personnel to perform work;
 - All property owners along ditch execute property access permission form and release; and
 - Other criteria that may be established by the Mathews County Board of Supervisors and/or the Department of Transportation.

Local and state agencies, at their discretion may give the aforementioned criteria different weights of importance in considering inclusion of the ditch on the list and its priority.

4. Ditches will only be considered for listing and ranking by the local and state agencies on a schedule to be established by these agencies.
